

**CITY COUNCIL MEETING**  
**03-20-2023**

The City Council of the City of Lineville met in their regular meeting on Monday, March 20<sup>th</sup>, 2023, at 5:00 p.m. at the City Annex Building in Lineville, Alabama, with the following present: Mayor Roy Adamson, Council Members: David Proctor, Carolyn Smith, Joseph Appleby, Rick Coleman, Larry Bishop, and City Clerk Nicholas New, Police Chief Richard Bickerstaff, Court Clerk Jodie McKinney, City Supervisor Rusty Taylor, and Breanna Minter from the Clay Times Journal.

Mayor Roy Adamson called the meeting to order. Mayor then asked the Council if they had reviewed the minutes from the previous Council meeting. A motion was then made by Council Member Proctor and seconded by Council Member Smith to approve the minutes from the previous meeting. The vote was unanimous. Next the Mayor asked the Council if they had reviewed the bills to be paid. A motion was made by Council Member Appleby and seconded by Council Member Coleman. The vote was unanimous.

First on the agenda was to distribute the 2021-2022 financial audits to be reviewed. Mayor Adamson mentioned that the Council will review the financial audits and approve them at the next Council Meeting.

Next on the agenda City Clerk New reads aloud Resolution 03-20-2023-01 to approve for the City to participate in the 2023 Back-to-School sales tax holiday, which will be July 21<sup>st</sup>-July 23<sup>rd</sup>. A motion was made by Councilmember Smith and seconded by Councilmember Appleby to approve this resolution. The vote was unanimous.

Councilmember Carolyn Smith asks the Council to vote to approve the library's free library program they are trying to start, contingent on the Council approving the locations of the free libraries. A motion was made by Councilmember Smith and seconded by Council Member Appleby to approve the free libraries. The vote was unanimous.

Councilmember Smith mentioned that the Alabama Historical Commission will do a presentation at the library on Thursday March 23<sup>rd</sup> at 3:30 and invites the Council to join them.

Councilmember Proctor reminds the Council that the annual Park Board golf tournament in Saturday March 25<sup>th</sup> at 9:00 A.M. and that they have 14 teams of three signed up currently.

Lastly Councilmember Proctor inquires about the property on Highway 9 beside the Burger Quick, Proctor asks if we have contact information for the owners of said property as he has a motivated business that is interested in it. City Supervisor Taylor says that he has contact information for the owner, but they seem to be hard to catch on the phone.

There being no further business a motion to adjourn was made by Council Member Coleman and seconded by Council Member Bishop. The vote was unanimous. The meeting ended at 5:11 P.M.
